## AN ORDINANCE ADOPTING THE 2024 UPDATE OF THE CITY OF GREEN LONG RANGE COMPREHENSIVE LAND USE PLAN.

WHEREAS, the City of Green originally adopted the Long Range Comprehensive Land Use Plan and Policy Guide in 1997 ("Land Use Plan"); and

WHEREAS, the City of Green amended the Land Use Plan in 2004 by Ordinance 2004-24; and

WHEREAS, the City of Green amended the Land Use Plan in 2014 by Ordinance 2014-16; and

WHEREAS, in 2022, the City commenced to update the Comprehensive Land Use Plan; and

WHEREAS, at its meeting on December 18, 2024, the Planning & Zoning Commission voted 5-0 to adopt the Comprehensive Land Use Plan update and to favorably recommend to City Council for the same; and

WHEREAS, City Council desires to conduct a public hearing on the 2024 update to the Comprehensive Land Use Plan.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

#### **SECTION ONE:**
