WHEREAS, on Monday, August 18, 2025, the City Engineer opened bids for the Project; and

WHEREAS, the City Engineer has reviewed the bids as shown in "Exhibit A" and recommends the contract be awarded to T and T Landscaping Contractors (Srokowski Construction) as the lowest and best bidder for the Project in the amount of \$81,678.53.
