AN EMERGENCY RESOLUTION DECLARING THE NECESSITY AND INTENTION TO APPROPRIATE FOR STREET PURPOSES CERTAIN FEE SIMPLE INTERESTS, TEMPORARY AND PERMANENT EASEMENTS IN AND TO VARIOUS PREMISES ALONG RABER ROAD, ALTOGETHER WITH THE NECESSARY APPURTENANCES TO BE FURTHER IDENTIFIED AS THE RABER ROAD MULTI-USE PATH PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, in promotion of the public interest of the residents of the City of Green, it is necessary for the City to appropriate for street purposes certain fee simple interests and easements in and to various premises to facilitate construction and implementation, altogether with the necessary appurtenances to be further identified as Raber Road Multi-Use Path Project "(Project"); and

WHEREAS, in accordance with Ohio Revised Code Section 719.05, only one reading of this Resolution shall be required.

WHEREAS, second reading passage is requested to secure all land for the Raber Road Multi-Use Path Project as ODOT requires before advertising for bids.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council deems it necessary and declares its intention to appropriate for street purposes certain fee simple interests and easements in various premises more fully described as follows:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.
