A RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) 2019 F-550 CHASSIS XL 4X4 SD CREW CAB 1 TON DUMP TRUCKS FROM GANLEY FORD, INC., FOR USE BY THE CITY'S SERVICE DEPARTMENT, AND DECLARING AN EMERGENCY.

WHEREAS, it has been determined that the City of Green needs two (2) new 2019 F-550 Chassis XL 4x4 SD Crew Cab 179' WB DRW 1 Ton Dump Trucks to maintain its streets and stormwater; and

WHEREAS, the City authorizes the purchase of (2) two 2019 F-550 Chassis XL 4x4 Crew Cab 1 Ton Dump Trucks from Ganley Ford, Inc as the best quoted price of Thirty-Nine Thousand Five Hundred Seventy-Three Dollars and Thirty-Six Cents (\$39,573.36) per truck.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

The Mayor is hereby authorized and directed to enter into a purchase agreement with Ganley Ford, Inc as the best quoted price of Thirty-Nine Thousand Five Hundred Seventy-Three Dollars and Thirty-Six Cents (\$39,573.36) per 2019 F-550 Chassis XL 4x4 SD Crew Cab 1 Ton Dump Truck, for a total amount not to exceed Seventy-Nine Thousand One Hundred Forty-Six Dollars and Seventy-Two Cents (\$79,146.72), a copy of which is attached hereto and incorporated herein as Exhibit "A".

SECTION TWO:

The requirement for competitive bidding is waived pursuant to Section 210.05 of the Codified Ordinances of the City of Green. Green City Council recognizes that individually these vehicles are below the cost for competitive bidding. Three (3) quotes were obtained for comparison pricing, a copy of which is attached hereto and incorporated herein as Exhibit "B".

SECTION THREE:

Green City Council authorizes the Finance Director to make payments to Ganley Ford, Inc through the established purchase order procedure.

SECTION FOUR:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FIVE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that the need

Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
