WHEREAS, the City has determined a need to provide additional youth baseball / softball fields for the community; and

WHEREAS, the Service Department has consulted with a local professional firm to design the fields, parking areas, landscaping, and other ancillary related items; and

WHEREAS, AECOM is an approved Professional Services firm through Resolution 2019-R108; and

WHEREAS, the City of Green Parks and Recreation Board supports and recommends AECOM for the expenditure of parks capital funds for the design and construction of additional fields at Greensburg Park, a copy of which is attached as **Exhibit "B"**. Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into an Agreement with AECOM for the design and construction of additional fields at Greensburg Park per their proposal of this Project, a copy of which is attached hereto as Exhibit "A". The Finance Director is authorized to make payment to AECOM through theestablished purchase order process.

SECTION TWO:

The Finance Director is authorized to appropriate the sum of Forty-Five Thousand Dollars (\$45,000.00) to the Greensburg Park Improvement Account (Acct #402-7900-53631) from the unappropriated balance of the Parks Capital Projects Fund.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason
