A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ACCEPT A DONATION FROM TOTH BUICK GMC FOR THE GREEN FIRE COMMUNITY PARAMEDICINE PROGRAM FOR THE PURCHASE OF A 2020 GMC TERRAIN SUV FROM TOTH BUICK, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, Toth Buick GMC would like to make a donation to the City of Green Fire Community Paramedicine Program in the amount of Twenty-Six Thousand Dollars (\$26,000.00); and

WHEREAS, Green City Council desires to formally accept the donation funds from Toth Buick GMC to use such funds to purchase a 2020 GMC Terrain SUV from Toth Buick to be used by Green Fire Community Paramedicine; and

WHEREAS, at the request of the Finance Director, Green City Council authorizes the deposit of such funds into the City's Fire/Paramedic Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:

SECTION ONE:

Green City Council formally accepts the donation from Toth Buick GMC in the amount of Twenty-Six Thousand Dollars (\$26,000.00) for the purchase of a 2020 GMC Terrain SUV from Toth Buick.

SECTION TWO:

Green City Council authorizes the donation to be deposited in the City's Fire/Paramedic Donation Account (Account# 210-0000-48300) in the amount of Twenty-Six Thousand Dollars (\$26,000.00) and to be appropriated into the Fire/Paramedic Vehicles Account (Account #210-3300-53650) from the unappropriated balance of the Fire/Paramedic Fund. Green City Council authorizes the purchase of a 2020 GMC Terrain SUV from Toth Buick; and, authorizes the Finance Director to make payments through the established purchase order procedure.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution was taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal action was in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green, and for the further reason that it is necessary to properly account for this donation on the City's books and records.
