A RESOLUTION AUTHORIZING THE CITY OF GREEN TO RENEW A CONTRACT WITH USIC LOCATING SERVICES, LLC FOR PROFESSIONAL UTILITY LOCATING SERVICES, FOR A THREE YEAR ONE YEAR ANNUALLY RECURRING TERM COMMENCING FEBRUARY 13, 2020, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green routinely contracts for various types of professional services with multiple firms; and

WHEREAS, as a result of passage of Ordinance 2010-04, it is necessary for City Council to approve the hiring of firms for the services; and

WHEREAS, the City has entered into similar agreements with other firms providing services pursuant to written agreements which are readily available to inspect and review; and

WHEREAS, it is necessary to appropriate funds to pay for the cost of the services; and

WHEREAS, the City is desirous in contracting for underground utility locating services to assist in construction projects throughout the City, as set forth in Exhibit "A", a copy of which is attached hereto.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the City of Green to enter into a contract with USIC Locating Services, LLC, for professional services.

SECTION TWO:

Green City Council authorizes the Finance Director to appropriate Thirty Thousand Dollars (\$30,000.00) to the Contracted Service Account (Acct #100-5200-52412) from the unappropriated balance of the General Fund. Green City Council further authorizes the Finance Director to make payment to USIC Locating Services, LLC for services provided through the established purchase order process.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.
