A RESOLUTION APPROVING FUNDING FOR THE RE-ESTABLISHING OF KLECKNER BASEBALL FIELDS PROJECT, AUTHORIZING AN APPROPRIATION FROM THE PIPELINE SETTLEMENT FUND, AND DECLARING AN EMERGENCY.

WHEREAS, it is the City's desire, with the recommendation of the Sports Impact Advisory Committee, to re-establish baseball fields at the former Kleckner School Property; and

WHEREAS, due to the proximity of the NEXUS Pipeline, Greensburg Field No. 4 has scheduled loss of the field; and

WHEREAS, the City has investigated the desirability and need to re-establish baseball fields at the former Kleckner School Property; and

WHEREAS, the City's Administration desires to proceed with the planning and construction of baseball fields at the former Kleckner School Property; and

WHEREAS, it is necessary to purchase materials, supplies, and contract with necessary contractors; and

WHEREAS, the City desires to use the NEXUS Settlement monies for re-establishing the baseball fields at the former Kleckner School Property; and

WHEREAS, in order to prepare for the 2019 Spring Baseball Season, the City Administration is requesting the use of direct contracting in lieu of competitive bidding.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT AND STATE OF OHIO, THAT:

SECTION ONE:

Green City Council approves re-establishing baseball fields on the Kleckner property.

SECTION TWO:

The Finance Director is authorized to appropriate the total sum of One Hundred Thousand Dollars (\$100,000.00) to the Kleckner Baseball Fields Project Account (acct#245-7870-53631) from the unappropriated balance of the Pipeline Settlement Fund. These expenses will be paid from the Nexus Settlement monies received by the City.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting of this Council and any deliberations of this City and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
