**A RESOLUTION AWARDING A CONTRACT TO THE JOSEPH A. JEFFRIES CO., INC FOR THE 2022 MISCELLANEOUS CONCRETE REPAIRS PROJECT, AND DECLARING AN EMERGENCY.**

WHEREAS, the City of Green advertised a “Notice to Bidders” in the Akron Beacon Journal on Wednesday, July 6, 2022; and, Wednesday, July 13, 2022; for the 2022 Miscellaneous Concrete Repairs (“Project”); and

WHEREAS, on Thursday, July 21, 2022, the City Engineer opened bids for the Project; and

WHEREAS, the City Engineer has reviewed the bids and recommends the contract be awarded to The Joseph A. Jeffries Co., Inc as the lowest and best bidder for the Project in the amount of One Hundred Forty-Seven Thousand One Hundred Sixty-Nine Dollars and Fifty-Six Cents (\$147,169.56); and

WHEREAS, the Administration is requesting second (2<sup>nd</sup>) reading passage on August 23, 2022 to ensure the contractor has enough good weather to finish the Project.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:**

**SECTION ONE:**

The City received and opened the following bids on July 21, 2022:

**SECTION TWO:**

Green City Council finds, based on all relevant factors, that The Joseph A. Jeffries Co., Inc with its total bid of One Hundred Forty-Seven Thousand One Hundred Sixty-Nine Dollars and Fifty-Six Cents (\$147,169.56), is the lowest and best bidder for the Project and agrees to comply with all specifications.

**SECTION THREE:**

The Mayor is authorized and directed to enter into an Agreement with The Joseph A. Jeffries Co., Inc for the Project. The Finance Director is authorized to make payments to The Joseph A. Jeffries Co., Inc through the established purchase order procedure.

**SECTION FOUR:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

**SECTION FIVE:**

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and so that the Project may proceed immediately and forthwith. Provided that this legislation receives the affirmative vote of three-fourths ( $\frac{3}{4}$  ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
