I have reviewed the bids for the 2021 Resurfacing Project. The totals are as follows:

After review, I have found Barbicas Construction Co, Inc. to be unresponsive due to their failure to comply with all of the City's bid submittal requirements. This rejection was a result of Barbicas Construction Co, Inc.'s failure to supply a bid guaranty and contract bond to the City of Green prior to the time and date of the bid opening.

Therefore, after further review, I have found Northstar Asphalt, Inc. to be the lowest, responsive, responsible bidder. Their bid guaranty and performance bond is provided by a surety company from the U. S. Treasury Department's approval list and is authorized to transact business in Ohio.

I am, therefore, recommending the introduction of legislation to award the contract to Northstar Asphalt, Inc. for Base Bid plus Alternate No. 4 for a total of \$1,634,724.70.
