AN ORDINANCE AUTHORIZING THE NECESSITY AND INTENTION OF APPROPRIATION PROCEEDINGS TO ACQUIRE LAND FOR AN ACCESS ROAD ON THE NORTH SIDE OF EAST TURKEYFOOT LAKE ROAD TO PROVIDE SAFE INGRESS AND EGRESS TO AND FROM THE ADJACENT PROPERTIES, AND MAKING AN APPROPRIATION.

WHEREAS, the City of Green has a need to provide safe ingress and egress on East Turkeyfoot Lake Road; and

WHEREAS, the City needs to undertake efforts to acquire property; and

WHEREAS, the purpose of this legislation is to declare the necessity and intention to appropriate for street purposes certain fee simple interests to facilitate construction and implementation of an access road approximately 260 feet east of the intersection of Massillon Road; and

WHEREAS, it is necessary to appropriate funds to purchase land for this project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council deems it necessary and declares its intention to appropriate for street purposes certain fee simple interests more fully described as follows:

SECTION TWO:

The Mayor is hereby authorized and directed to cause written notice of the passage of this Ordinance, along with the statutory notice required by Ohio Revised Code Section 163.041, to be given to the owners or persons in possession or having an interest of record in the various premises, and that such notice shall be served and returned according to law.

SECTION THREE:

The Finance Director is authorized to appropriate the sum of **Eighty-Four Thousand Dollars** (\$84,000.00) Seventy Five Thousand Dollars (\$75,000.00), to the Land Account (Acct. #100-1900-53610) from the unappropriated balance of the General Fund.

SECTION FOUR:

This Council finds and determines that all formal actions of this Council and of any of its committees concerning and relating to the passage of this Ordinance were taken, and that all deliberations of this Council and of any committees that resulted in those formal actions were held, in meetings open to the public in compliance with the law.
