#### VII. Levi J. Hartong/Southgate Farm Signage Discussion

Ms. Haring stated that this sign will look similar to the Lichtenwalter sign they discussed last year. It will be the same size and the location will be in the vicinity of the farm complex closer to the barn and the house are located. The sign is designed to inform pedestrians and visitors what happens on the farm and the different things they do. Ms. Haring stated she is looking for a discussion and a recommendation or to table this item because of numerous changes they would like to make.

Mr. Schweikert stated that he thinks all the signs are well crafted, however the sign that has the Southgate logo on it twice is his least favorite. Ms. Penedo stated she likes the sign with the bullet points, it's easier to read. Ms. Cenker asked if the font could be darker so it would be easier to read and more eye-catching; she likes the bullet points as well. Ms. Tanner stated she is in favor of the sign with bullet points but thinks there should be some capitalization for the first word of each line.

Mr. Schreckenberger asked what the size would be. Ms. Haring stated it will be 24x36. Mr. Schreckenberger asked if there was consideration for more than one location. Ms. Haring stated not at this time, The Parks Division has a lot of way finding signage in Boettler Park and they are going to do the same with Southgate Farm this year. Ms. Haring stated pedestrians come in from 3 different access points and they may consider more signs in the future.

There was some discussion regarding the size of the font and making it easier to read and eliminating the duplication of the Southgate Farm logo.

Ms. Haring stated from a purist historical standpoint, it should say Levi J. Hartong Farm, but that's not what it's doing right now. She stated she embedded the language in the narrative. There was some discussion on how and where the Levi J. Hartong Farm could be incorporated into the sign.

### X. Planning Department Report - Sarah Haring Community Development Admin.

Ms. Haring stated the Planning Department submitted a grant to the Ohio and Erie Canalway Coalition to receive money for Design and Engineer for a walkway at Lichtenwalter Schoolhouse. She explained where the walkway would be located on the property out of the front door to the lower level of the schoolhouse.

She also shared some information on CLG (Certified Local Government), she stated this is what the HPC is. It explains who they are and what they do, they can go to the website for more information.

Ms. Haring stated she has been in contact with Richard Edwards and the proprietors of The Industry; they would like to get them a historical plaque to go on the building since they are open for business now.

The city is embarking on a Public Art Plan Initiative and have received 14 proposals from consultants to help develop a plan. The scoring committee has narrowed it down to 4 consultants, they will be interviewed the last 2 weeks of April.

### XI. Green Historical Society Report

Mr. Schweikert gave a brief update on the Lichtenwalter Schoolhouse and what events are coming up for the summer and how people can volunteer.
