Furthermore, it represents an unnecessary overreach by local government aimed at generating additional revenue, which is neither essential nor warranted.

In an era where self-sufficiency is increasingly important, it is vital to encourage individuals to provide for themselves and their families without undue overreach of local, state, and federal government oversight. Therefore, the proposed revisions to the ordinance, particularly the removal of existing exceptions, would be a welcome change.

First of all, THANK YOU! I really appreciate that our community is willing to look into the ordinances and find areas of improvement and most importantly act on them!

I would like to share my support for most of the proposed changes.

The restrictions for number of hens by acreage is very restrictive still (8 hens can live in a 12ft run - it certainly doesn't require a full acre to handle that). Further, why no roosters? Outside of breeding, they offer many benefits. Previous ordinance I believe allowed roosters for acreage over 5, why completely remove them now? How will the few farms we have left around Green feel about that?

We have a lot of predators around us - especially those of us on properties of the size to have larger flocks, roosters offer protection, help keep the flock safe, improve the behavior of the flock overall, and can even help increase egg production.

Please consider your reasons for your restrictions and consider whether they are for the greater good or protection of a few.
