A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ACCEPT A GRANT UNDER THE FISCAL YEAR 2020 ASSISTANCE TO FIREFIGHTERS GRANT FROM THE U.S. DEPARTMENT OF HOMELAND SECURITY, AUTHORIZING THE CITY'S MATCHING FUNDS TO PURCHASE AND INSTALL FIRE ALARM SYSTEMS FOR STATION #1 AND STATION #2, AND EXTRICATION EQUIPMENT, MAKING AN APPROPRIATIONS, AND DECLARING AN EMERGENCY.

WHEREAS, Green City Council authorized the Mayor to apply for an Assistance to Firefighters Grant ("Grant") for the purchase and installation of fire alarm systems at Fire Station #1 and Fire Station #2, as well as new extrication equipment with Resolutions 2021-R08 and 2021-R09; and

WHEREAS, the City of Green has been awarded the Grant in the total amount of One Hundred Five Thousand Twenty-Five Dollars and Nine Cents (\$105,025.09) for both Grants now combined into one Grant by the U.S. Department of Homeland Security; and

WHEREAS, the matching local share not to exceed ten percent (10%); and

WHEREAS, the City will use the Grant to purchase fire alarm systems and extrication equipment totaling One Hundred Fifteen Thousand Five Hundred Twenty-Seven Dollars and Sixty Cents (\$115,527.60); and

WHEREAS, the City of Green accepts the Grant in accordance with the Agreement Terms.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:

## **SECTION ONE:**

Green City Council authorizes and directs the Mayor to accept the Fiscal Year 2020 Assistance to Firefighters Grant from the U.S. Department of Homeland Security the in the amount of One Hundred Five Thousand Twenty-Five Dollars and Nine Cents (\$105,025.09). The City's portion of the Grant totals One Hundred Fifteen Thousand Five Hundred Twenty-Seven Dollars and Sixty Cents (\$115,527.60).

## **SECTION TWO:**

Green City Council authorizes an appropriation of One Hundred Fifteen Thousand Five Hundred Twenty-Seven Dollars and Sixty Cents (\$115,527.60) to the following accounts: Fire Alarm System Station #1 (Acct #100-7100-53632)=\$3426.00; Fire Alarm System Station #2 (Acct #100-7500-53632) = Two Thousand Seven Hundred Sixteen Dollars (\$2,716.00) from the unappropriated balance of the General Fund; Extrication Equipment (Acct #218-3220-53641) = Four Thousand Three Hundred Sixty Dollars and Fifty-One Cents (\$4,360.51) from the unappropriated balance of the Ambulance Transportation Fund; Fire Alarm System Fire Station #1 & Fire Station #2 (Acct #232-3300-53632) = Fifty-Five Thousand Two Hundred Seventy-

Eight Dollars (\$55,278.00); Extrication Equipment (Acct #232-3220-53641) = Forty-Nine Thousand Seven Hundred Forty-Seven Dollars and Nine Cents (\$49,747.09) from the unappropriated balance of the Federal Grant Fund.

## **SECTION THREE:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution was taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal action was in meetings open to the public, in compliance with all legal requirements.

## **SECTION FOUR:**

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths (¾ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
