**RESOLUTION NO.:** 2024-R79

**SPONSOR:** MAYOR YEARGIN

INTRODUCED: NOVEMBER 26, 2024 ASSIGNED TO:

A RESOLUTION CREATING THE POSITION OF ASSISTANT PLANNING DIRECTOR IN THE PLANNING DEPARTMENT, ESTABLISHING COMPENSATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green administration wishes to provide internal promotional opportunities when appropriate, for professional growth and retention purposes, although without adding staff; and

WHEREAS, certain positions such as an Assistant Planning Director potentially enable the City of Green administration to experience an easier transition for the succession of leadership within the organization;

WHEREAS, the addition of an Assistant Planning Director will allow management flexibility in appointing and promoting not currently available within the Planning Department; and

WHEREAS, it is necessary to establish a rate of compensation for the Assistant Planning Director position.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

#### **SECTION ONE:**

Green City Council establishes the position of Assistant Planning Director, as described in Exhibit A. The Assistant Planning Director is established as a pay grade 12 with a minimum of \$37.35 per hour (\$77,688 annualized) and a maximum of \$56.02 per hour (\$116,522 annualized).

#### **SECTION TWO:**

Pursuant to the Charter of the City of Green the Assistant Planning Director position will be non-bargaining, FLSA exempt, and unclassified and exempt from Civil Service Rules and Regulations.

#### **SECTION THREE:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

#### **SECTION FOUR:**

Green City Council authorizes additional appropriations to the affected line items of the budget, as computed and authorized by the Director of Finance. to accommodate the salary adjustments.

### **SECTION FIVE:**

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
