WITH REPUBLIC SERVICES COMPETITIVELY BID BY
THE CITY OF GREEN FOR REFUSE COLLECTION AND DISPOSAL AND CURBSIDE
RECYCLING AND YARD WASTE COLLECTION

RESOLUTION NO. 211028-01

The Coventry Township Board of Trustees met in special session on October 28, 2021, at the Coventry Town Hall, 68 Portage Lakes Drive, Coventry Township, Ohio 44319. All Trustees were recorded present.

All formal actions of this Board concerning and relating to the adoption of this Resolution were made at an open meeting of the Board and all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Jeff Houck moved adoption of the following Resolution:

WHEREAS, Ohio Revised Code Section 9.48 permits a political subdivision to participate in a contract that another political subdivision has competitively bid for the "acquisition of equipment, materials, supplies or services"; and,

WHEREAS, the TOWNSHIP OF COVENTRY desires to contract exclusively with REPUBLIC SERVICES for refuse, yard waste, and recycling services; and,

WHEREAS, the CITY OF GREEN has entered into a contract with REPUBLIC SERVICES for refuse collection and disposal and curbside recycling services with contract having been competitively bid by the CITY OF GREEN; and,

WHEREAS, the TOWNSHIP OF COVENTRY hereby requests that it be permitted to participate in the contract with REPUBLIC SERVICES as entered into by the CITY OF GREEN; and

WHEREAS, the collection and disposal of trash and recyclables is necessary for the immediate preservation of the public health, safety and welfare of the TOWNSHIP OF COVENTRY.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWNSHIP OF COVENTRY, STATE OF OHIO:

SECTION 1. That the BOARD OF TOWNSHIP TRUSTEES is hereby authorized to conduct negotiations with REPUBLIC SERVICES competitively bid through the CITY OF GREEN, for refuse collection and disposal and curbside recycling and yard waste services on the terms and conditions contained in the contract entered into by the CITY OF GREEN, and on such further terms contained in the contract between the TOWNSHIP OF COVENTRY and REPUBLIC SERVICES.

SECTION 2. All residences in the TOWNSHIP OF COVENTRY will have trash service, yard waste and recycling exclusively with REPUBLIC SERVICES in accordance with the contract between the TOWNSHIP OF COVENTRY and REPUBLIC SERVICES. A residence is defined in said contract.

SECTION 3. Provided this Resolution receives the affirmative vote of at least two Board members, it shall take effect immediately upon its adoption and approval; otherwise, it shall take effect and be in force at the earliest time provided by law.
