Presentation by Dan Risko, Director of Public Affairs **RE: State Treasurer's Ohio Check Book**

Mr. Schmidt has completed the migration to a new financial package and now will work on the Ohio Check Book. Dan Risko gave the background of the Ohio Check Book. In 2014 Ohio was ranked 46 for transparency. He talked about how Ohio changed the process and how it works. The following year Ohio ranked number 1 in transparency for the country. He briefly showed how to look things up on Ohio Check Book.

Mr. Humphrey asked how many years of data it will compile. Mr. Risko said there is no limit. He asked if there would be a link on the website and Mr. Schmidt said there would be. It went live today.

Mr. Shaughnessy asked how it affects our City and what is the costs. Mr. Schmidt said there is no cost to the City and he will update once a month. Mr. Risko said they work with most accounting providers.

Mayor Neugebauer asked if they could get 2016 on the system. Mr. Risko said it can be done easily.

Mr. Speight asked who is responsible for the Ohio Check Book. Mr. Risko said it would be Finance Director Steve Schmidt but it has been locked. Mr. Schmidt said no employees personal information is included.

Mr. Young said he knew about the bats because he has sat on the Planning and Zoning Committee for three years. He is disappointed at how council uses this

platform by saying false truths.

Mr. Shaughnessy said those are not his words. It is a quote in the paper.

Mayor Neugebauer said the other attributed the statement to you but it was not a quote. He talked about Mr. Shaughnessy's access to the Administration. He also talked about the timing of the referendum. He talked about how this is tearing the community apart. Mr. Shaughnessy and Mayor Neugebauer bantered back and fourth.

Mrs. Babbitt gave a statement regarding her vote and social media. She asked everyone involved in this process employ civility. She said it is possible to disagree without being disagreeable.

Mr. Yeargin said his recollection that the bats were not discussed. He talked about the conversation with outside counsel. He talked about Oberlin who did not vote for the settlement.
