A RESOLUTION AUTHORIZING EMERGENCY ROOF REPAIRS TO THE HIGHWAY TRUCK GARAGE, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green Service Department is the public entity responsible for protecting and preserving the materials and equipment of the Highway, Storm Water, and Parks Divisions, and

WHEREAS, the current roof has deteriorated, and

WHEREAS, the existing roof of an essential storage structure needs major repair, and

WHEREAS, the Service Department has obtained the necessary quotes, and

WHEREAS, the proposed is of an emergency nature to further protect city assets.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

SECTION ONE:

The Finance Director is authorized to appropriate the total sum of Forty Thousand Dollars (\$40,000.00) to the Roof Repairs Improvement Account (Acct#100-7400-53631) from the unappropriated balance of the General Fund.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting of this Council and any deliberations of this City and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths ($\frac{3}{4}$ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
