V. Public Report

Mr. Humphrey reviewed the procedure and talked about the procedure that was followed on February 7. He advised that all questions that were asked at the February 7, meeting, that were not rhetorical questions, are answered on a document on the website.

Tony Ziehler, 3883 Golden Wood Way - Mr. Ziehler said it was time to stop being angry and focus on things we can still have an impact. He offered for consideration, focus the resources on looking and observing the construction and operation as it goes in. He said the individual monitoring may need training. He said there may be merit to conducting a study to identify the 5-10 areas that are at the greatest risk. Evaluate preventative measures. He said the Nexus website advertises how this distribution system is going to be tapped in throughout the state. He thinks that may provide some development opportunities in the City of Green. He said the City should establish some goals on how we are going to try to maximize the benefits from this agreement.

Pat Carleski, 3878 Greenfield - She commended the council members for their vote. She said she did not think less of any of them for their vote. She encouraged them to look at the citizens needs. Be open and transparent. She gave several suggestions for the procedure and follow-up. She thanked each one of them.

Joe Petrella, 5373 Thursby Road - He talked about studying some of the cause and affects.

Safety

-Pipelines expel gases and other carcinogens at different levels including but not limited to the pumping stations. (This gas you will not be able to smell due to Nexus refusing to put Mercaptan in the gas.)

-These carcinogens are a documented cause of several cancers including but not limited to Bladder,MDS,AML etc

-One of these,Benzene has a documented history in the Akron area due to the tire industry. They used this ingredient to cure tires for many years.

-People are more or less sensitive to these carcinogens depending on their immune system. Children more than adults since they have an undeveloped adaptive(develop over your life)immune system and only have an innate one.(born with)

Property devaluation

-City of Green published that the devaluation of the typical property would be between 2 1/2 and 5%. Some more some less depending on location. What is the City going to do to address this? These property owners MUST be compensated especially within the blast zone to be able to move and sell their property.

-Lastly, I talked about the decision made by some council members as well as the Mayor to rush this through. Their vote would have been different if it affected their property. Finally, they will be held responsible, totally and fully if any mishaps happen including Green residents health.

Greer Kabb-Langkamp - 465 Comet Lane - She read a statement about her disappointment with the procedure that was done.

Tammy Daly, 1779 King Drive - She presented her concerns with the process.

- I have concerns that the full City Council didn't even know this legislation was about Nexus until the executive session held Monday.

-

- I have concerns that two new members of council only had three days to study this issue and another was on vacation until the night of the vote

-

- I have concerns that the legislation was passed in three days with barely an hour of citizen comment and zero citizen questions answered.

-

- I have concerns that not a single Green resident publicly supported the legislation during that hour of testimony yet four of you voted against the people's voices.

-

- I have concerns that...the \$7.5 million in the settlement isn't nearly enough to offset the \$125 million loss to the community, let alone the public safety threat this agreement poses to the city

-

- I have concerns that not enough safety issues were included in the settlement: automatic shut off valves, smell additives, well testing w/in a quarter mile, and an independent 3rd party hired by the city to monitor the pipeline (not Nexus' crew). And I directly oppose the city's memo saying wells can't be affected. As natural gas production increases in the U.S, so, too, have reports of well water contaminated with methane.

- I have concerns that the city may not be following the city charter that says No resolution or ordinance shall become effective until thirty (30) days after its passage. Yet in the last couple of days the city has already filed to dismiss the active appeals you had in court. And they were active appeals that were dismissed by the City Of

Green, not the courts.

• I have concerns that council is no longer listening to residents and no longer working for your constituents...Since the Mayor and four members of City Council weren't interested in listening to its residents a week ago, maybe they will listen to us at the ballot box. Green's charter says any legislation not passed by a ¾'s majority can be placed on the ballot. I understand you will fight the referendum too bc in the Nexus settlement you agreed in writing to "cooperate with Nexus to oppose any efforts by third parties to challenge this agreement." So now we'll probably watch our city wage a PR attack against the residents instead of Nexus. Some of us are not giving up!
