A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO AN AGREEMENT WITH POD DESIGN FOR DESIGN CONCEPT OF RECREATION FACILITIES AND AMENITIES AT KREIGHBAUM PARK, AND DECLARING AN EMERGENCY.

WHEREAS, the City desires to make professional master planning and landscape architectural designs for the improvements to Kreighbaum Park; and

WHEREAS, the Service Department has issued and received responses for a Request for Qualifications Statement from various firms including Brandstetter Carroll, Inc., Designing Local, Environmental Design Group, and POD Design; and

WHEREAS, the City of Green Parks and Recreation Board supports the recommendation of the Administrative Committee and the expenditure of parks capital funds for the design concept of Kreighbaum Park.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into an Agreement with POD Design to provide professional park master planning and landscape architectural design services for Kreighbaum Park, a copy of which is attached hereto as Exhibit "A". The Finance Director is authorized to make payment to POD Design through the established purchase order process.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that this is an appropriation of money. Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
