A RESOLUTION AWARDING A CONTRACT TO CAVANAUGH BUILDING CORPORATION FOR THE KLECKNER PARK IMPROVEMENTS PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green desires to make improvements to Kleckner Park; and

WHEREAS, the City of Green advertised a "Notice to Bidders" in the Akron Beacon Journal on Tuesday, July 5, 2022 and, Tuesday, July 12, 2022 for the Kleckner Park Improvement Project ("Project"); and

WHEREAS, on Wednesday, July 20, 2022, the City Engineer opened bids for the Project; and

WHEREAS, the City Engineer has reviewed the bids and recommends the Contract be awarded to Cavanaugh Building Corporation as the lowest and best bidder for the Project in the amount of One Hundred Seventy-Seven Thousand Eight Hundred Seven Dollars (\$177,807.00), and Alternate #1 in the amount of Thirteen Thousand One Hundred Eighty-Six Dollars (\$13,186.00) for a total Project cost of Two Hundred Ten Thousand Ninety-Two Dollars and Thirty Cents (\$210,092.30), which includes a Ten Percent (10%) contingency.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

The City received and opened the following bids on July 20, 2022:

SECTION TWO:

Green City Council finds, based on all relevant factors, that Cavanaugh Building Corporation, with its total bid of One Hundred Ninety Thousand Nine Hundred Ninety-Three Dollars (\$190,993.00), is the lowest and best bidder for the Project and agrees to comply with all specifications.

SECTION THREE:

The Mayor is authorized and directed to enter into a Contract with Cavanaugh Building Corporation. for the Project. The Finance Director is authorized to make payments to Cavanaugh Building Corporation through the established purchase order procedure.
