A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO A CONTRACT WITH AKHIA COMMUNICATIONS TO PROVIDE SPECIALIZED PUBLIC RELATION SERVICES REGARDING THE MASSILLON ROAD SOUTH ROUNDABOUT PROJECT, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green wishes to procure the services of a public relations firm to provide certain public relations and communication services regarding the Massillon Road South Roundabout Project; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into an Agreement between the City of Green and Akhia Communications for public relation services based upon the scope of services, which is attached hereto and incorporated herein as Exhibit "A", regarding the Massillon Road South Roundabout Project; and

SECTION TWO:

Green City Council authorizes the Finance Director to make payment to Akhia Communications Services for public relation services through the established purchase order process.

SECTION THREE:

The Finance Director is authorized to appropriate the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) to the Massillon Rd/Corporate Woods Account, also known as "Massillon Road South" (Acct #201-2100-53633) from the unappropriated balance of the Street Construction, Maintenance & Repair Fund.

SECTION FOUR:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FIVE:

Green City Council declares this to be an emergency necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that public relation services are required to proceed immediately to ensure that the communications services can be timely commenced and timely completed. Provided that this legislation receives the affirmative vote of three-fourths ($\frac{3}{4}$ ths) of the members elected
