Mr. Shaughnessy commented that he was encouraged to hear about bigger ponds. Concerns with traffic and communication are a bigger issue and he cannot support the legislation.

Mr. Yeargin commented that shielding the residents from commercial development is important. He believes the city has done what it can to protect the residents with larger ponds and expanding Arlington Rd. etc. and he will support the legislation.

Mr. Dyer stated he too was concerned about communication, but supports the legislation because of all the good dialog between the developers and the City. He also stated that there will be several opportunities to address issues while the development goes through the DRB and PZC etc.

Mr. Humphrey explained that no matter how well you try to communicate, someone always gets missed or feels they were not properly notified. The City is very transparent and makes all documents and agendas available to residents. All projects boil down to traffic and stormwater. The stormwater issues go back to the 1940's and the retention ponds and keeping sediment from crossing the road will most certainly help things. He is supportive of the legislation.
