A RESOLUTION AWARDING A CONTRACT TO SIGNAL SERVICE COMPANY FOR THE MAYFAIR EAST STREET LIGHT REPLACEMENT PROJECT ("PROJECT"), MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green advertised a "Notice to Bidders" in the Akron Beacon Journal on October 2, 2019 and October 9, 2019; and

WHEREAS, the City opened bids on Wednesday, October 30, 2019; and

WHEREAS, the Administration reviewed the bid and recommends the contract be awarded to Signal Service Company for the Project, and

WHEREAS, it is necessary to appropriate funds to pay for the cost of the project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

The City received and opened the following bids on Wednesday, October 30, 2019, at 2:00 pm.

SECTION TWO:

Green City Council finds, based on all relevant factors, that Signal Service Company is the lowest and best bidder for the Project, and it has agreed to comply with all specifications for the Project.

SECTION THREE:

The Mayor is authorized and directed to enter into an agreement with Signal Service Company for the Project. The Finance Director is authorized to make payments to Signal Service Company through the established purchase order procedures.

SECTION FOUR:

Green City Council authorizes the Finance Director to appropriate One Hundred Thirty-Nine Thousand Four Hundred Fifty-Five Dollars (\$139,455.00) to the Contracted Repairs/Install account (acct# 216-2230-52412) from the unappropriated balance of the Street Lighting Assessment Fund.

SECTION FIVE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION SIX:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that this is an appropriation of money. Provided that this legislation receives the affirmative vote of three-fourths ($\frac{3}{4}$ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
