## V. Public Report

Joel Helms, 4977 Massillon Road - Mr. Helms addressed his concerns with the procedure that was done for 2018-R10. He advised he seen no reference to 2015-R05 which would be repealed with this new legislation. He reviewed several rules and charter sections that he believes were not followed.

Tammy Daly, 1779 King Drive - Mrs. Daly came to ask for help with the well issue. She referred to the Rover pipeline. She stated there is contamination during the process not after it is in. She addressed the different zones that can be contaminated. She also addressed the blast zone and what the actual distance could be.

The Mayor said the only place directional drilling will take place is by the reservoir. He said there will be inspections so we will know if there are leaks during drilling. He advised there is water testing that can be done through the city before hand. He said they certainly can have the blast zone calculated by an outside person. He talked about the distance from the pipeline and the football fields at Ariss Park.

Mr. Humphrey asked the Mayor to put on the website how citizens can get their well tested.

Mrs. Daly advised the Ohio EPA has Ohio certified labs listed.

Des Wertheimer, 130 E. Turkeyfoot Lake Road - He talked about directional drilling and how it is done. He said most water companies can do several types of water testing. The blast zone - He talked about the other areas in the city that are within a blast zone. Romania in WWII was the largest oil field. He talked about the security and safety of the schools. He thought we should come up with a plan to help make the schools safe.

Tom Ebbott, 882 Killinger Road - He said he is not in the route or in the kill zone. He said a month ago we were united and three weeks ago we became divided. He asked Council to unite. If the people want to have a referendum vote you should let them have it.

Mayor Neugebauer gave his Mayor's report.

#### XI. Unfinished Business

Mr. Dyer appreciated the sentiments of Mr. Ebbott regarding healing. He asked for clarification if the City was going to oppose the referendum officially or not so we are transparent with those in the community. He talked about his concerns that the City did not follow the 30 day rule and would like more clarification on that issue. He is not convinced that the legislation is exempt from the 30 day rule. The Charter is pretty clear that all resolutions that don't pass by emergency, which this did not, take 30 days to take affect. He asked for more clarification on the thirty day issue and would also like to learn from the Administration by the next meeting if there is going to be an actual fight on the referendum so the City can be as transparent with the public as possible.

Mr. Shaughnessy said he just signed up for the Nexus pipeline texts.

Mr. Humphrey said he appreciated Mr. Ebbott's comments. He talked about his time on council and his concerns with how this is splitting the city. Most votes are 7-0 because Council is making the best decision with the information they have. No matter how that vote went there was going to be angry and unhappy people. FERC decided the pipeline was going to be here, not the City of Green. He asked the community to bring it down a level. No one wants this pipeline here. He advised they were told that if we did not have a settlement agreement, they would proceed through eminent domain and the City would get next to nothing. He listed all the things the City would not have gotten if they did not have a settlement agreement. He talked about information that has been given regarding referendum. When he voted for the settlement agreement he did the best he could to understand the risk to the community and to make the best decision that he could. He talked about making the decision with integrity and professionalism. Citizens have a right to circulate a referendum petition, absolutely it is in the Charter. The pipeline is still coming through Green weather there is a referendum or not. He finds it very offensive that people are saying that you need to allow the people to speak. He asked what people are they talking about. He said there are 26,000 people in the City of Green and Council represents all of them, not just the 1,000 that sign a petition to say they disagree. He respects their right to disagree but they have to also understand at the end of the day as a City, as a Council, as a law director they have to uphold the law. He wishes this would go away tomorrow but it isn't going to and the reason it is not going to is because people are upset and he understands that and he is upset too. If a referendum is not able to go through, ultimately it is not Chris Humphrey or any member of Council deciding if the referendum is going through, it will be the board of elections, a court, we are subject in this country to a role of law and that process is going to take place. His plea to the community is to lets listen to each other, talk to each other, bring it down a 100 notches and understand, after all of this is done we are friends, neighbors and co-workers and all part of this community together. He asked people before they

started to get angry to stop and listen.

Mr. Yeargin said he echoed the concerns raised by Mr. Ebbott and Mr. Dyer is correct about making sure we get accurate information out. Whatever decision is to be made by a community, it is important it is based on the truth. Part of his frustration is that it was pending litigation and Council could not speak regarding the matter because of attorney client privilege. Mr. Yeargin said there is a divide in the community. He gave some thoughts on how the Council came to the settlement so quickly on a factual basis so that people understand what the facts were before Council. He reviewed his pros and cons. He explained that the court will retain jurisdiction and he explained the benefits. He pointed out Nexus must meet weekly with the City. If Nexus doesn't do what the law requires them to do, we can hold them accountable. He highlighted things from the settlement agreement and because of that agreement we can take them right back to court and without the agreement we couldn't do that. The last thing that fell in favor of the settlement agreement for him was holding out for more money risked no accountability for public safety. The timing was advised by outside counsel and advised leverage was at our highest point.

Mr. Dyer did take issue with the con side of his argument. Mr. Dyer's decision had nothing to do with selfish reasons, it was based on what he thought was a deeply flawed document. He was concerned about the process with less than an hours input and the original intent was to do it at one meeting with very little input. He had many concerns with the agreement and they were heartfelt. The outside legal counsel admitted he had zero experience cutting these types of deals. He respected the legal counsel's ability to understand environmental law and to be fair to him, not many of cut deals like this throughout the country. He said he appreciated the president letting members speak, he thought it was healthy and a good discussion that should be had. It was better here then social media. He asked that those on all sides of this issue acknowledge that the votes that were taken were of integrity. He said his concerns aren't based on politics but the Charter and they need to find out answers.

Mr. Humphrey said he thinks they all wished that they would have had 30 or 60 days to think about this issue. He said the reality is we were at the sixth circuit and our counsel had done a fantastic job arguing to three judges and they had fast tracked the case. The last piece of leverage the City had against Nexus could have evaporated in four hours after that oral argument. When that court ruled, there went the City's leverage. He hopes this discussion has shed some light and some facts and lowers the tempeture here in the City.

Mr. Shaughnessy said this has turned into a re-litigation of the Nexus vote. He would have liked to seen that during the meetings that were had with regards to Nexus. He said there is a value into explaining our votes but it has turned into a re-litigation.
