A RESOLUTION REQUIRING THE SUMMIT COUNTY FISCAL OFFICER TO ADVANCE FUNDS TO THE CITY OF GREEN, AND DECLARING AN EMERGENCY.

WHEREAS, before and subsequent to tax settlement dates during each fiscal year, the City of Green will require funds for the continuity of services, which funds are drawn from General Operating Funds; and

WHEREAS, Council respectfully requests the Summit County Fiscal Officer to advance funds and deduct such advances from funds due this City but not yet distributed.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:

SECTION ONE:

Green City Council requests and authorizes the Summit County Fiscal Officer to advance funds to the City of Green, and that the amount of such advance or advances be charged to the City of Green and deducted from funds due the City but not distributed. The Clerk shall certify a copy of this Resolution to the Summit County Fiscal Officer each January 1 for tax year 2019 payable in 2020.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that the Project is set to proceed immediately. Provided that this legislation receives the affirmative vote of three-fourths ($\frac{3}{4}$ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
