AN ORDINANCE ESTABLISHING CHAPTER 1072, ELECTRIC VEHICLE CHARGING STATIONS, WITHIN TITLE SIX – OTHER PUBLIC SERVICES – GRANTING AUTHORITY TO THE MAYOR TO ESTABLISH A FEE SCHEDULE FOR MUNICIPALLY OWNED VEHICLE CHARGING STATIONS.

Whereas, the City of Green obtained grant funds used to install electric vehicle charging stations at the Central Administration Building; and

Whereas, the City of Green should establish regulations and a fee schedule for the public's consumption and use of the charging stations at municipal facilities; and

Whereas, it is the intent of the City of Green to charge such fees to cover the cost of electricity provided to the vehicles by the charging stations, the life cycle costs of maintenance and replacement of the charging stations, and any additional costs associated with the charging stations and parking spaces at the Central Administration Building and other municipal locations.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

SECTION ONE:

Chapter 1072 Electric Vehicle Charging Stations of Title Six – Other Public Services - of Green's Codified Ordinances is hereby established.

SECTION TWO:

The Green City Council hereby authorizes the Mayor to establish a fee schedule for the electronic charging stations to be charged to and paid by the operator of any vehicle occupying a designated municipal charging parking space and/or using the charging equipment.

SECTION THREE:

The fee schedule shall be reviewed annually to confirm that the fees comport with the average Ohio electric utility rate and charged at a kWh rate.

SECTION FOUR:

The payments collected by the municipal electric charging stations shall be used to defray the expense of electricity provided and the life cycle costs to maintain and replace station equipment.

SECTION FIVE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
