A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO A LEASE AGREEMENT FOR THE PURCHASE OF MISCELLANEOUS EQUIPMENT FOR USE AT THE RAINTREE GOLF AND EVENT CENTER, AND DECLARING AN EMERGENCY.

WHEREAS, it has been determined that the City needs various grooming and maintenance equipment for use at the Raintree Golf and Event Center to maintain its courses; and

WHEREAS, the City has entered into an agreement with Billy Casper Golf, LLC, to operate and manage Raintree Golf and Event Center; and

WHEREAS, the Service Director and Billy Casper Golf, LLC, have jointly determined the current equipment, which was part of the initial purchase of the Raintree Country Club property, is obsolete and inadequate to maintain the grounds at Raintree Golf and Event Center; and

WHEREAS, the new maintenance equipment will be purchased through the State of Ohio Cooperative Purchasing Program and/or Billy Casper Golf, LLC national vendor accounts for the best pricing to optimize savings.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SCTION ONE:

The Mayor is hereby authorized and directed to enter into a lease agreement through Billy Casper Golf, LLC, for the lease to own agreement of various grooming and maintenance equipment, as is more fully set forth in the equipment package proposal attached hereto and incorporated herein as Exhibit "A".

SECTION TWO:

The requirement for competitive bidding is waived pursuant to Section 210.05 of the Codified Ordinances of the City of Green. Green City Council recognizes the individual equipment items are below the cost for competitive bidding and understands many of the purchases will be made in accordance with the State of Ohio Cooperative Purchasing Program.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that the need for this equipment is immediate. Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
