AN ORDINANCE AMENDING CHAPTER 1226, SECTION 1226.01 TABLE 1226-1: ALLOWABLE USES AND CHAPTER 1226, SECTION 1226.02: USE-SPECIFIC REGULATIONS AND CHAPTER 1231, SECTION 1231.02: DEFINITIONS TO ADD CHILDREN'S GROUP HOME AS AN ALLOWED LAND USE.

WHEREAS, the City of Green desires to amend its Land Development Code in order to include children's group homes as an allowed use.

WHEREAS, at its regularly scheduled meeting on August 17, 2022, the City of Green Planning & Zoning Commission made a favorable recommendation to City Council for the proposed text amendment by a vote of 5-0.

### **SECTION ONE:**

The City of Green Codified Ordinance Chapter 1226, Section 1226.01 Table of Allowed Uses, Table 1226-1 shall be amended as set forth in Exhibit "A", a copy of which is attached hereto and incorporated herein by reference.

# **SECTION TWO:**

The City of Green Codified Ordinance Chapter 1226, Section 1226.02 Use-Specific Regulations shall be amended as set forth in Exhibit "B", a copy of which is attached hereto and incorporated herein by reference.

### **SECTION THREE:**

The City of Green Codified Ordinance Chapter 1231, Section 1231.02: Definitions shall be amended as set forth in **Amended** Exhibit "C", a copy of which is attached hereto and incorporated herein by reference.

# **SECTION FOUR:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this ordinance were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

# **SECTION FIVE:**

This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
