WHEREAS, the duly appointed TIRC met on October 26, 2021 to review the Tax Increment Financing Agreements and Community Reinvestment Area Agreements, reviewed each business's compliance with each Agreement, and made certain recommendations to either continue, modify, or terminate each Agreement; and

WHEREAS, pursuant to Ohio Revised Code §5709.85, the Council of the City of Green is required to either accept, reject, or modify all or any portion of the recommendations of the TIRC within sixty (60) days.
