**A RESOLUTION IN SUPPORT OF ENTERING INTO AN AGREEMENT WITH THE GREATER AKRON CHAMBER OF COMMERCE TO IMPLEMENT THE SUMMIT COUNTY SMALL BUSINESS EMERGENCY RELIEF GRANT PROGRAM TO ASSIST BUSINESSES LOCATED IN THE CITY OF GREEN, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.**

WHEREAS, Summit County has developed a COVID-19 Small Business Emergency Relief (“SBER”) Grant Program; and

WHEREAS, Summit County has engaged the Greater Akron Chamber of Commerce to manage the COVID-19 SBER Grant Program; and

WHEREAS, the City of Green desires to participate in the Grant Program developed by Summit County and administrated by Greater Akron Chamber of Commerce; and

WHEREAS, it is necessary to appropriate funds to participate in the program.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:**

**SECTION ONE:**

Green City Council supports participating in the Summit County COVID-19 Small Business Emergency Relief Grant Program to assist the businesses impacted by the COVID-19 pandemic located in the City of Green.

**SECTION TWO:**

Green City Council authorizes the Mayor to enter into the Grant Agreement between the City of Green and the Greater Akron Chamber of Commerce, a copy of which is attached hereto as Exhibit “A”.

**SECTION THREE:**

The Finance Director is authorized to appropriate the sum of Fifty Thousand Dollars (\$50,000.00) from the General Fund Account (Acct# 100-1300-52862) and make payment to the Greater Akron Chamber of Commerce.

**SECTION FOUR:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal action were in meetings open to the public, in compliance with all legal requirements.

**SECTION FIVE:**

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation

receives the affirmative vote of three-fourths ( $\frac{3}{4}$  ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
