A RESOLUTION AWARDING A CONTRACT TO FINLEY FIRE EQUIPMENT FOR THE PURCHASE OF A SELF-CONTAINED BREATHING APPARATUS (SCBA) AIR COMPRESSOR, MAKING AN APPROPRIATION, AND **DECLARING** EMERGENCY.

WHEREAS, the City of Green was awarded and accepted an Assistance to Firefighters Grant ("Grant") for the purchase of a new air compressor; and

WHEREAS, the City of Green advertised a "Notice to Bidders" in the Akron Beacon Journal on Thursday, December 13, 2018; and, Thursday, December 20, 2018, for the purchase of a 2018 SCBA Air Compressor; and

WHEREAS, on Monday, January 14, 2019, the bids were received and opened for this purchase; and

WHEREAS, the Fire Chief has reviewed the bids and recommends the Contract be awarded to Finley Fire Equipment, as the lowest and most responsive and responsible bidder for the purchase in the amount of Fifty-Nine Thousand Seven Hundred Ninety-Nine Dollars (\$59,799.00).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council approved Resolution 2018-R72 authorizing the City of Green to accept a grant under the Fiscal 2017 Assistance to Firefighters Grant from the U.S. Department of Homeland Security and authorized the matching funds from the City to purchase an air compressor.

SECTION TWO:

The City received and opened the following bids on January 14, 2019:

SECTION TWO:

City Council finds, based on all relevant factors, that Finley Fire Equipment is the lowest and most responsive and responsible bidder for the purchase and agrees to comply with all specifications. The Fire Chief has recommended awarding the bid to Finley Fire Equipment in the amount of Fifty-Nine Thousand Seven Hundred Ninety-Nine Dollars (\$59,799.00).

SECTION THREE:

Green City Council authorizes the Finance Director to appropriate Fifty-Three Thousand Eight Hundred Nineteen Dollars and Ten Cents (\$53,819.10) to the Air Compressor Equipment Account (Acct#232-3300-53646) from the unappropriated balance of the Federal Grant Fund and Five Thousand Nine Hundred Ninety-Seven Dollars and Ninety Cents (\$5,979.90) to the Air Compressor Equipment Account (Acct #210-3300-53646) from the unappropriated balance of the Fire/Paramedic Fund, as the required ten percent match from the City to accept the Grant. Green City Council further authorizes the Finance Director to make payment to Finley Fire Equipment for the purchase provided through the established purchase order process.

SECTION FOUR:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FIVE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths (¾ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
