A RESOLUTION AUTHORIZING THE TRADE-IN OF THE 1998 SEWER TRAILER MOUNTED SEWER SECA 747 CLEANING EQUIPMENT USED BY THE CITY'S SERVICE DEPARTMENT TO OFFSET A PORTION OF THE PURCHASE PRICE OF A NEW T-SERIES RAMJET (SEWER JET) TRAILER, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green has budgeted and authorized the purchase a new T-Series Ramjet Trailer (Sewer Jet) to maintain its stormwater from Jack Doheny Supplies Ohio, Inc, through the Sourcewell Purchasing Program, Contract #122017-FSC; and

WHEREAS, the City's Service Director has determined the current City owned equipment, a 1998 Sewer Trailer Mounted SECA 747, is no longer adequate or useful to provide services; and

WHEREAS, Green City Council wishes to authorize the trade-in of the 1998 Sewer Trailer Mounted SECA 747 to Jack Doheny Supplies Ohio, Inc, to offset a portion of the new equipment purchase price.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

The 1998 Sewer Trailer Mounted SECA 747 is hereby declared surplus municipal property, no longer of useful service to the City of Green.

SECTION TWO:

The Mayor is hereby authorized and directed to sell and trade-in the 1998 Sewer Trailer Mounted Sewer SECA 747 to Jack Doheny Supplies Ohio, Inc and receive a credit in the amount of Seventeen Hundred Dollars (\$1,700.00) to apply to the purchase of the new T-Series Ramjet Trailer (Sewer Jet), a copy of which is attached hereto and incorporated herein as Exhibit "A". The Finance Director is authorized to make payment to Jack Doheny Supplies Ohio, Inc, through the established purchase order procedure.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.


SECTION FOUR:
