AN ORDINANCE AUTHORIZING THE INSTITUTION OF APPROPRIATION PROCEEDINGS AGAINST VARIOUS PROPERTY OWNERS OF REAL PROPERTY ALONG STATE ROUTE 619, PICKLE ROAD, FOR SR 619/PICKLE ROAD ROUNDABOUT PROJECT ("PROJECT"), AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green has undertaken a plan to improve the intersection of State Route 619 and Pickle Road to construct a roundabout; and

WHEREAS, the Project will commence in the Spring of 2018; and

WHEREAS, as part of the Project, the City has undertaken efforts to acquire property, both permanently and temporarily, from the respective owners; and

WHEREAS, the City of Green has been unable to reach an agreement with the respective property owners; and

WHEREAS, it is critically important that the City of Green obtain possession of the properties immediately so there are no delays in the commencement and completion of the Project as further described in the Plans and Specifications for the Project on file with the City which are incorporated herein by reference as if fully rewritten.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes legal counsel to take all legal action necessary, including filing a lawsuit to appropriate and obtain possession of the necessary portions of real property owned by the respective property owners referenced below and identified by the corresponding parcel number(s) to insure the Project is commenced and completed as scheduled:

SECTION TWO:

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green to ensure that the SR 619/Pickle Road Roundabout Project begins and is completed on time. Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
