WHEREAS, it is necessary for City Council to accept the tax rates for the fiscal year commencing January 1, 2026; and WHEREAS, the Budget Commission of Summit County, Ohio, has certified its action on the tax budget to this Council with the County Fiscal Officer's estimate of the rate of each tax necessary to be levied by this Council, and what part is without, and what part is within, the ten-mill limitation. NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT: **SECTION ONE:** City Council accepts the amounts and rates as determined by the Budget Commission in its Certification, which is attached hereto and incorporated herein as Exhibit "A". **SECTION TWO:** The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements. **SECTION THREE:** Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that the Project is set to proceed immediately. Provided that this legislation receives the affirmative vote of threefourths (3/4ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
