**RESOLUTION NO.:** 2025-R56 **SPONSOR: MAYOR YEARGIN** PRESENTED BY: LAW DIRECTOR DEAN INTRODUCED: **NOVEMBER 10, 2025** ASSIGNED TO: A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE COUNTY OF SUMMIT FOR AN ANIMAL CONTROL CONTRACT, AND **DECLARING AN EMERGENCY.** WHEREAS, in 1989, the Village of Green entered into an Agreement for Animal Control Services with the County of Summit; and WHEREAS, the Agreement automatically renewed each year; and WHEREAS, the County of Summit issued a written Notice of Termination that the Agreement expired on August 31, 2025; and WHEREAS, the City of Green and the County of Summit desire to enter into a new Agreement for Animal Control Services: and WHEREAS, the City desires to utilize the services of the County Animal Control Manager, as set forth in the Agreement attached as Exhibit "A". NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT: **SECTION ONE:** Green City Council authorizes the Mayor to enter into an agreement with the County of Summit for an Animal Control Service Contract, attached herein to this legislation as Exhibit "A", with such modifications and revisions as shall be in furtherance of the provisions of said agreement and not substantially adverse to the City, and any necessary related documents and appropriate funds. **SECTION TWO:** The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting of this Council and any deliberations of this City and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements. **SECTION THREE:** Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
