Reference is made to your request dated February 21, 2020 for additional compensation to complete plans for the subject Project.

The City agrees that additional services are required and further agrees that this Modification represents an adjustment of prime compensation for a net increase of Thirty-Two Thousand Seven Hundred Sixteen Dollars (\$32,716.00), allocated to the following work items:

"Part 1: PL and PE Phases

Actual costs plus a net fee of Eighty Thousand Three Hundred Fifty-Six Dollars (\$80,356.00). However, the maximum prime compensation shall not exceed One Million One Hundred Ninety-Four Thousand Nine Hundred Thirty-

Four Dollars (\$1,194,934.00).

Part 2: Additional Planning Level Traffic

Actual costs plus a net fee of Two Hundred Sixty-Seven Dollars (\$267.00). However, the maximum prime compensation shall not exceed Three Thousand Seventy-Four Dollars (\$3,074.00).

Part 3: Phase 1 History/Architecture Survey - DELETED

Part 4: Attendance at ten (10) Project Meetings.

Actual costs plus a net fee of Two Hundred Thirty-Seven Dollars (\$237.00) per meeting, However, the maximum prime compensation shall not exceed Three Thousand Twenty-Five Dollars (\$3,025.00) per meeting. The total maximum compensation for eight (8) meetings shall not exceed Twenty-Five Thousand Three Hundred Eighty-Three Dollars (\$25,383.00).

Part 5: Additional Public Meeting

Actual costs plus a net fee of Two Thousand One Hundred Ninety-Three Dollars (\$2,193.00). However, the maximum prime compensation shall not exceed Twenty-Five Thousand One Hundred Thirty-Three Dollars (\$25,133.00).

Part 6: EE Phase

Actual costs plus a net fee of Twenty-Five Thousand Six Hundred Twenty-Eight Dollars (\$25,628.00). However, the maximum prime compensation shall not exceed Three Hundred Eighty-Two Thousand Three Hundred Seventy-One Dollars (\$382,371.00).

Part 7: Right of Way Plans

Actual costs plus a net fee of Thirteen Thousand Two Hundred Thirty-Nine Dollars (\$13,239.00). However, the maximum prime compensation shall not exceed One Hundred Fifty-Five Thousand Two Hundred Thirty-Seven Dollars (\$155,237.00).

Part 8: Retaining Wall Plans

Actual costs plus a net fee of Six Thousand One Hundred Seventy-Two Dollars (\$6,172.00). However, the maximum prime compensation shall not exceed Sixty-Eight Thousand Eight Hundred Sixty-Six Dollars (\$68,866.00).

Part 9: Stream and Wetland Opportunities Inventory Report

Actual costs plus a net fee One Thousand Eight Hundred Thirty-Six Dollars (\$1,836.00). However, the maximum prime compensation shall not exceed Twenty-One Thousand One Hundred Fifty-Eight Dollars (\$21,158.00).

Part 10: Culvert Detail Plans

Actual costs plus a net fee Four Hundred Forty-Eight Dollars (\$448.00). However, the maximum prime compensation shall not exceed Five Thousand Eight Dollars (\$5,008.00).

Part 11: Water Work Plans

Actual costs plus a net fee Eight Thousand Five Hundred Seventy-Six Dollars (\$8,576.00). However, the maximum prime compensation shall not exceed One Hundred Twenty-Eight Thousand Four Hundred Seventy-Seven Dollars (\$128,477.00).

Actual costs plus a net fee Four Thousand Eight Hundred Twenty-One Dollars (\$4,821.00). However, the maximum prime compensation shall not exceed Fifty-Four Thousand Sixty-Seven Dollars (\$54,067.00).

Actual costs plus a net fee Thirty-Two Thousand Eight Hundred Twenty-Eight Dollars (\$32,828.00). However, the maximum prime compensation shall not exceed Four Hundred One Thousand One Hundred Thirteen Dollars (\$401,113.00).

Part 14: Right of Way Pinning

Actual costs plus a net fee One Hundred Nine Dollars (\$109.00). However, the maximum prime compensation shall not exceed Nine Thousand Six Hundred Thirty-Three Dollars (\$9,633.00).

Part 15: Right of Way Acquisition Services

Unit of Work Compensation as established in the table below. The maximum prime compensation shall not exceed Two Hundred Seventy-Nine Thousand Four Hundred Fifty Dollars (\$279,450.00). All work shall be performed on an "if authorized" basis. The fee shall accumulate as authorized (separate cost accounting is not required for each activity).

Additionally, it is expressly understood by the parties that none of the rights, duties and obligations described in this Modification shall be binding on either party until such time as the expenditure of funds is certified by the Director of Budget and Management, pursuant to Section 126.07 of the Ohio Revised Code.
