# A RESOLUTION AWARDING A CONTRACT TO BARBICAS CONSTRUCTION CO, INC. FOR THE 2025 RESURFACING PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green advertised a "Notice to Bidders" in the Akron Beacon Journal on Tuesday, February 11, 2025; and, Tuesday, February 18, 2025, for the 2025 Resurfacing Project ("Project"); and

WHEREAS, on Wednesday, February 26, 2025, the City Engineer opened bids for the Project; and

WHEREAS, the City Engineer has reviewed the bids and recommends the contract be awarded to Barbicas Construction Co, Inc. as the lowest and most responsive and responsible bidder for the Project in the amount of \$721,769.45, as detailed in Exhibit A.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

#### **SECTION ONE:**

The City received and opened the following bids on Wednesday, February 26, 2025:

#### **SECTION THREE:**

The Administration seeks to reduce the typical ten percent (10%) contingency to four percent (4%) of the awarded contract for the 2025 Resurfacing Project.

#### **SECTION FOUR:**

The Mayor is authorized and directed to enter into an agreement with Barbicas Construction Co, Inc. for the Project. The Finance Director is authorized to make payments to Barbicas Construction Co, Inc. through the established purchase order procedure.

Provided that this legislation receives the affirmative vote of three-fourths (¾ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
