I have reviewed the bids for the Ariss Park Improvements Project. The totals are as follows:

After review, I have found Cavanaugh Building Corporation to be unresponsive due to their failure to comply with all of the City's bid submittal requirements. This rejection was a result of Cavanaugh Building Corporation's failure to supply a bid guaranty and contract bond to the City of Green prior to the time and date of the bid opening.

Therefore, after further review, I have found Marks Construction Inc. to be the lowest and best bidder. Their bid guaranty and performance bond is provided by a surety company from the U. S. Treasury Department's approval list and is authorized to transact business in Ohio.

I am, therefore, recommending the introduction of legislation to award the contract to Marks Construction Inc. for a total bid of \$385,329.86.
