Mr. France briefly explained the history with the Sheriff's office. He advised the contract would start on January 1, 2021 and run through December 31, 2023. The total of the three year package is \$9,374,838.97. He explained what this paid for. Mayor Neugebauer spoke about body cameras that were added two years ago and explained where that is in the contract. Mr. France talked about the service from the Sheriff's office. Mrs. Carey Dean added, regarding the body camera, the Sheriff's Office did indicate that for now they don't know the cost of manning the records management. They don't know the cost of making sure those records that are requested or may be used, so they added in the scope of services may be amended to include the cost of increased staffing related to that and the City as a party of the agreement will be able to review that prior to implementation. She just wanted to make sure the public and Council were made aware that there may be an additional cost. Mr. Yeargin asked if the number in the contract, related to deputy hours, cars and total cost, how they reflect from the current contract. Mr. Schmidt explained. He advised that for 2022 and 2023 it is 2.8% increases for both years with the same number of deputies. Mrs. Babbitt asked if the contract gave the flexibility to add another officer if they want to do that. Mayor Neugebauer said it would just be a modification to the contract and the Administration would go back to Council with that. With no questions, Mr. France asked for Time and it was Granted.
