A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO AN AGREEMENT WITH ENVIRONMENTAL DESIGN GROUP (EDG) FOR THE DEVELOPMENT OF SITE IMPROVEMENT PLANS FOR KLECKNER PARK, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City recently completed the Kleckner Park Adaptive Field project; and

WHEREAS, the City desires to make all fields accessible to persons with all abilities; and

WHEREAS, the City desires to make improvements to the existing ballfields including accessible sidewalks, spectator areas, dugouts, additional fencing, and other site improvements including an accessible playground and accessible pavilion; and

WHEREAS, the installation of accessible pathway and accessible facilities meets strategy 1.2.2 of the parks comprehensive master plan and satisfies the recommendation of the parks division ADA Assessment performed in 2023 (SKULSKI CONSULTING) meeting the requirement of Section 206 Chapter 4 (Accessible Routes) of the Americans with Disabilities Act; and

WHEREAS, the City of Green Parks and Recreation Board supports the recommendation of the Service Department to make site improvements to Kleckner Park.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into an Agreement with Environmental Design Group not to exceed Twenty Four Thousand Nine-Hundred Dollars and Zero Cents (\$24,900.00) for Site Improvement Plans for Kleckner Park, based upon the scope of services, a copy of which is attached hereto and incorporated herein as Exhibit "A".

SECTION TWO:

Green City Council authorizes the Finance Director to appropriate the sum of Twenty-Four Thousand Nine-Hundred Dollars and Zero Cents (\$24,900.00) to the Kleckner Park Construction Account (Acct# 402-7870-53630) from the unappropriated balance of the Parks Capital Reserve Fund.

SECTION THREE:

Green City Council authorizes the Finance Director to make payment to Environmental Design Group not to exceed Twenty-Four Thousand Nine-Hundred Dollars and Zero Cents (\$24,900.00) for this project through the established purchase order procedure.

SECTION FOUR:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any

deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FIVE:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that the need for this is immediate. Provided that this legislation receives the affirmative vote of three-fourths ($\frac{3}{4}$ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
