A RESOLUTION AUTHORIZING THE CONFIRMATION OF THE APPOINTMENT OF DR. ALEXSANDRA MAMONIS AS THE CITY OF GREEN REPRESENTATIVE TO SERVE ON THE SUMMIT COUNTY COMBINED GENERAL HEALTH DISTRICT BOARD OF HEALTH FOR A FOUR (4) YEAR TERM BEGINNING JANUARY 1, 2020 AND ENDING DECEMBER 31, 2023, AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code Section 3709.07 for the union of city and general health district and Green City Council is desirous of uniting the City Health District with the Summit County General Health District; and

WHEREAS, the City of Green will be without personnel to provide the health services pursuant to general law, and such services are necessary; and

WHEREAS, Dr. Alexsandra Mamonis has been the representative for the City of Green Board of Health since January 2004 with the term expiring December 31, 2019; and

WHEREAS, it is the desire of the Mayor of the City of Green to appoint Dr. Alexsandra Mamonis as the City of Green Board of Health representative for the Summit County Combined General Health District for a four (4) year term beginning January 1, 2020.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:

### **SECTION ONE:**

Green City Council authorizes the reappointment of Dr. Alexsandra Mamonis as the City of Green representative to service on the Summit County Combined General Health District Board of Health for a four (4) year term beginning January 1, 2020 and ending December 31, 2023.

### **SECTION TWO:**

It is hereby found and determined that this Resolution complies with Ohio Revised Code Section 121.22 regarding notifications of meetings and all deliberations of Green City Council pertaining hereto have been conducted in accordance therewith.

#### **SECTION THREE:**

This Resolution shall be in full force and effect from and after its adoption and approval by the Mayor or at the earliest period allowed by law.

### **SECTION FOUR:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

## **SECTION FIVE:**
