## Greetings,

My name is Lt. Chris Plance, Bomb Squad Commander for the Summit County Sheriff's Office. I received your concern through Detective Larry Brown. On the date and time that you heard the explosions, the Summit County Bomb Squad along with the Akron FBI Special Agent Bomb Technicians, were conducting a National Improvised Explosive Familiarization (NIEF) course. We had invited all the Police Chiefs or their designees in Summit County to this presentation to educate them on homemade explosive mixtures, precursors, and the dangers they present. The NIEF course is a national program developed by the FBI for first responders. We have been trained to conduct this course at our facility. The Sheriff's demolition range is specifically constructed for demolition operations. Although the sound of an explosion may travel quite a distance depending on atmospheric conditions, the damaging overpressure will not.

On November 8th, we demonstrated 9 different explosive mixtures to the class. This is why you heard multiple explosions.

We conduct the NIEF course multiple times throughout the year to educate our first responders in recognizing the dangers of homemade explosives for their safety and the public's safety.

We contact a number of agencies prior to these demonstrations, including a post on the Summit County Sheriff's Facebook and Twitter accounts.
