A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT GRANT FUNDS A FROM THE PUBLIC UTILITIES COMMISSION OF OHIO (PUCO), TO FUND A HAZARDOUS MATERIALS TRAINING CLASS FOR ALL FIRE DEPARTMENT PERSONNEL AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green Fire Division has applied for a grant through the Public Utilities Commission of Ohio. The Public Utilities Commission of Ohio is offering a grant award in the amount of Six Thousand One Hundred Dollars (\$6,100.00), to reimburse for annual Hazardous Materials training; and

WHEREAS, Fire Division personnel need to annually review the proper techniques for initial hazardous materials response, focusing on victim rescues, emergency decontamination, and safety in structural gear and SCBA.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT AND STATE OF OHIO, THAT:

SECTION ONE:

The Mayor is hereby authorized to accept the award for the 2025 Public Utilities Commission of Ohio Hazardous Materials Training Grant, and to provide all information and documentation required for funding assistance.

SECTION TWO:

Green City Council agrees to obligate the funds required to satisfactorily complete the proposed training and become eligible for reimbursement under the terms of the PUCO program. The Finance Director is authorized to make payments through the established purchase order process.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green and so that the deadline can be met. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
