

A RESOLUTION AWARDING A CONTRACT TO MELWAY PAVING CO., INC. FOR THE 2019 PARKS PAVEMENT MAINTENANCE, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green advertised a "Notice to Bidders" in the Akron Beacon Journal on Thursday, February 14, 2019; and, Thursday, February 21, 2019, for the 2019 Parks Pavement Maintenance ("Project"); and

WHEREAS, on Friday, March 1, 2019, the City Engineer opened bids for the Project; and

WHEREAS, the City Engineer has reviewed the bids and recommends the contract be awarded to Melway Paving Co., Inc. as the lowest and most responsive and responsible bidder for the Project in the amount of Seventy-Eight Thousand One Hundred Eighty Dollars and Sixty-Nine Cents (\$78,180.69).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

The City received and opened the following bids on March 1, 2019:

SECTION TWO:

City Council finds, based on all relevant factors, that Melway Paving Co., Inc. with its total base bid of Seventy-Eight Thousand One Hundred Eighty Dollars and Sixty-Nine Cents (\$78,180.69), is the lowest most responsive and responsible bidder for the Project and agrees to comply with all specifications.

SECTION THREE:

The Mayor is authorized and directed to enter into an agreement with Melway Paving Co., Inc. for the Project. Green City Council authorizes the Finance Director to appropriate Twenty-Six Thousand Dollars (\$26,000.00) to the Boettler Park Paving Maintenance Account (Acct# 402-7800-53634) from the unappropriated balance of the Parks Capital Project Reserve Fund. Green City Council further authorizes the Finance Director to make payments to Melway Paving Co., Inc. through the established purchase order procedure.

SECTION FOUR:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FIVE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and so that the Project may proceed immediately and forthwith. Provided that this legislation receives the affirmative vote of threefourths (3/4 ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
