A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO A CONTRACT WITH ENVIRONMENTAL DESIGN GROUP, LLC TO PROVIDE MUNICIPAL ENGINEERING SERVICES FROM JANUARY 1, 2026, THROUGH DECEMBER 31, 2028, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green wishes to procure the services of an engineering firm to provide certain engineering and construction inspection/administration services; and

WHEREAS, the City of Green followed the Revised Code requirements for quality based selection of engineering services; and

WHEREAS, Environmental Design Group, LLC was the highest ranked firm in the quality based selection process; and

WHEREAS, a Contract for engineering services has been negotiated with Environmental Design Group, LLC; and

WHEREAS, Environmental Design Group, LLC, and its predecessors, have provided engineering services to the City since 1993; and

WHEREAS, the current Contract with Environmental Design Group, LLC will expire on December 31, 2025; and, the City Engineer and Director of Planning have recommended that the City enter into a new Contract with Environmental Design Group, LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into a Contract between the City of Green and Environmental Design Group, LLC for engineering services for the term of January 1, 2026 through December 31, 2028, attached as Exhibit "A", a copy of which is attached hereto and incorporated herein.

SECTION TWO:

Green City Council authorizes the Finance Director to make payments to Environmental Design Group for engineering services through the established purchase order process.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths (3/4th) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
