A RESOLUTION AUTHORIZING THE MAYOR TO APPROVE THE CAPITAL IMPROVEMENT COMMUNITY PARK, RECREATION/CONSERVATION PROJECT PASS THROUGH GRANT AGREEMENT SUMM-023C FOR THE WILLADALE SEGMENT – SOUTHGATE CONNECTOR TRAIL PROJECT - MANAGED BY THE OHIO DEPARTMENT OF NATURAL RESOURCES, AND DECLARING AN EMERGENCY.

WHEREAS, the State of Ohio, through the Ohio Department of Natural Resources (“ODNR”), administers the 2020 Capital Improvement Community Park, Recreation/Conservation Project Pass Through Agreements; and

WHEREAS, the City of Green has been awarded Fifty Five Thousand Dollars (\$55,000.00) in financial assistance pursuant to Senate Bill No. 310, for costs associated with the Willadale Segment-Southgate Connector Trail Project; **and**

WHEREAS, an emergency exists for the reason that the State Controlling Board is scheduled to approve this Agreement on June 13, 2022. The Grant Agreement must be approved by Green City Council before ODNR can execute the Agreement which typically takes place 3-5 business days after Controlling Board Approval. This is the reason why second reading passage is requested on June 14, 2022.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT AND STATE OF OHIO, AS FOLLOWS:

SECTION ONE:

1. The Mayor is authorized to enter into a Grant Agreement for the City of Green Project SUMM-023C “Willadale Segment – Southgate Connector Trail”.
- ~~2. The Mayor is authorized to obligate the funds required to satisfactorily complete Phase I of Willadale Trail, as described within **Amended** Exhibit “A”, a copy of which is attached, and become eligible for reimbursement under the terms of the Agreement.~~

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green and so that the deadline can be met. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
