WHEREAS, the City of Green advertised a "Notice to Bidders" in the Akron Beacon Journal on Tuesday, February 25, 2025; and, Tuesday, March 04, 2025, for the Graybill Road Turn Lane Project at Green Elementary School ("Project"); and

WHEREAS, on Wednesday, March 12, 2025, the City Engineer opened bids for the Project; and

WHEREAS, the City Engineer has reviewed the bids and recommends the contract be awarded to Barbicas Construction Co. Inc as the lowest and most responsive and responsible bidder for the Project in the amount of \$191,301.00.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

#### **SECTION ONE:**

#### **SECTION TWO:**

City Council finds, based on all relevant factors, that Barbicas Construction Co. Inc with its total base bid of \$191,301.00, is the lowest most responsive and responsible bidder for the Project and agrees to comply with all specifications.

#### **SECTION THREE:**

The Finance Director is authorized to appropriate the sum of Two Hundred Ten Thousand Four Hundred Thirty-One Dollars (\$210,431.00) to the Graybill Rd Turn Lane Account (Acct. #201-2100-53671) from the unappropriated balance of the Street Construction, Maintenance and Repair Fund for construction of the project. The Finance Director is also authorized to appropriate the sum of Forty-Three Thousand Three Hundred Sixty-One Dollars (\$43,361.00) to the Graybill Rd Turn Lane Account (Acct. #201-2100-53671) from the unappropriated balance of the Street Construction, Maintenance and Repair Fund for related construction management services.

#### **SECTION FOUR:**

The Mayor is authorized and directed to enter into an agreement with Barbicas Construction Co. Inc for the Project. The Finance Director is authorized to make payments to Barbicas Construction Co. Inc through the established purchase order procedures.

#### **SECTION FIVE:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

#### **SECTION SIX:**

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and so that the Project may proceed immediately and forthwith. Provided that this legislation receives the affirmative vote of three-fourths (¾ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
