A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO A CONTRACT WITH CLOUDPOINT GEOSPATIAL, INC. FOR PROFESSIONAL SERVICES FOR THE INSTALLATION AND CONFIGURATION OF ARCGIS ENTERPRISE, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green desires to expand the GIS (Geographic Information Systems) program to setup additional employees and departments the ability to utilize GIS technology in a secure and managed approach; and

WHEREAS, the City of Green has been working closely with ESRI, Inc., the leading GIS software provider, to develop a strategy for advancing the use of GIS for the City of Green; and

WHEREAS, an amount of Thirty Thousand Dollars (\$30,000) was budgeted in the 2024 operating budget for GIS consulting; and

WHEREAS, three GIS professional services providers were interviewed resulting in the selection of CloudPoint Geospatial, Inc; and

WHEREAS, the City desires to enter into a contract with CloudPoint Geospatial, Inc in the amount of Sixteen Thousand Four Hundred Dollars (\$16,400) for the installation, configuration, and training of ArcGIS Enterprise; and

WHEREAS, the administration is requesting second reading passage to enter into the contract by the end of 2024 and encumber the necessary funds.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into the Contract with CloudPoint Geospatial, Inc. for GIS Professional Services, attached hereto as Exhibit A.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green, and for the further reason that it is necessary to properly account for this donation on the City's books and records. Provided that this legislation receives the affirmative vote of three-fourths (3/4th) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise, it shall take effect and be in force at the earliest time allowed by law.
