A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO AN AGREEMENT WITH THE COUNTY OF STARK CONCERNING THE MT. PLEASANT STREET/PITTSBURG AVENUE/MAYFAIR ROAD ROUNDABOUT PROJECT, PID 107649, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the intersection of Mt. Pleasant Street and Pittsburg Avenue/Mayfair Road is located in Jackson Township, Stark County (the “County”) and the City of Green, Summit County (the “City”); and

WHEREAS, it is in the best interests of the Stark County Engineer and the City of Green to improve the roadways and intersection; and

WHEREAS, the Stark County Engineer has secured Congestion Mitigation Air Quality (“CMAQ”) and Transportation Enhancement (“TE”) Federal Funds for Eighty Percent (80%) of the costs to improve the intersection; and

WHEREAS, the County will apply for Ohio Public Works Commission (“OPWC”) funding for the Project,

WHEREAS, the Project is scheduled to be awarded between July 1, 2022 and June 30, 2023; and,

WHEREAS, it is necessary for Green City Council to authorize the City of Green to enter into an Agreement, a copy of which is attached hereto as Exhibit “A”, via the adoption of Resolution 2021-R53.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into an Agreement between the City of Green and the Board of County Commissioners of Stark County, Ohio concerning the improvements of Mt. Pleasant Street and Pittsburg Avenue/Mayfair Road intersection. The terms of the Agreement are attached hereto and incorporated herein as Exhibit “A”.

SECTION TWO:

The Finance Director is authorized to appropriate the sum of One Hundred Thousand Dollars (\$100,000.00) to the Mt Pleasant/Pittsburg/Mayfair Road RoundAbout Account (#201-2100-53631) for this Project from the unappropriated balance of the Street Construction Maintenance & Repair Fund. Green City Council further authorizes the Finance Director to make payment to the County of Stark through the established purchase

order process.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Green City Council declares this to be an emergency necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that public relation services are required to proceed immediately to ensure that the communications services can be timely commenced and timely completed. Provided that this legislation receives the affirmative vote of three-fourths ($\frac{3}{4}$ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
